Dear Resident,

It is our understanding that you recently became a resident of the Village of Woodlawn, Welcome!

At this time, we would like to inform you of the Woodlawn Income Tax Ordinance and The basic provisions which relate to residents, as follows:

- 1.) The rate is 2% on all income, qualifying wages, commissions and other compensation and the net profit of businesses, professions, rental and other activities.
- 2.) Interest, dividends, pension income, unemployment and military pay are not taxable.
- 3.) All residents 18 years and older must file an annual earnings tax return.
- 4.) Credit for tax paid to another municipality is limited to 2% of wages taxed.

In order to determine your tax status with respect to the Woodlawn Tax, you are required to complete the enclosed forms and **return them to us within 15 days.**

The Tax Ordinance provides for a fine, imprisonment and dismissal for any person Divulging confidential information obtained through tax sources. This gives assurance That your information will be held in strict confidence.
